## **Course Description**

This qualification reflects the role of individuals who lead a frontline team and manage day-to-day operations of a retail store or department to implement and deliver on organisational objectives and standards. These individuals possess a range of highly developed selling and customer engagement skills with sound knowledge of product and service offerings. They work with independence, taking responsibility for their own functions and outputs.

This qualification provides a pathway to work in a diverse range of retail settings including speciality retailers, supermarkets, department stores, and quick service restaurants.

Individuals with this qualification are able to perform roles such as store manager, department manager and assistant store manager.

#### **Oualification**

Students successfully completing the course will receive the Nationally Recognised qualification; SIR40316 Certificate IV in Retail Management.

#### **Course Duration**

This course is offered full time over 1 year or 52 weeks including holidays on a full time basis.

## **Retail Management**

### **Entry Requirements**

Entry to this qualification is open to individuals who:

- have achieved a Certificate III in Retail
- have relevant industry employment experience in a job role that has involved the application of skills and knowledge described in core units of competency from the SIR30216 Certificate III in Retail.

#### **Age Requirements**

ANC has a requirement that all students must be over 18 years of age at the commencement of course.

#### **Academic Requirements**

To gain entry to this course, applicants should have successfully completed home country equivalent to an Australian Year 11 qualification.

#### **English Language Requirements**

All International Students applying for courses at AITT must have a minimum English Language proficiency level of one of the below:

- Successful completion of Senior Secondary certificate of education in Australia conducted in medium of English;
- Completion of a full time studies in Australia towards a Certificate III level course or above;
- English as the first language;
- Satisfactory completion of the EAL course OR
- Any other form of test which satisfies the Institution.

#### **Teaching Method**

Teaching is conducted in the classroom. The delivery will include face to face teaching, lectures, discussions, research, learning activities and group work.

#### Assessments

Assessments comprise of written assignments, projects, case studies, and observation. Skills will be assessed using role plays or simulated activities, set up for the purpose of assessment, in a simulated industry environment.
